**CAPLA DEMON** has raced 9 times, winning once and being placed 5 times. Since qualifying for a handicap mark he has never been beaten more than 4.5 lengths in any race. He won over 6F at Leicester in August and has been placed at Chelmsford, Thirsk, Kempton, Ffos Las & Southwell.

A strong, compact gelding, he shows a willing attitude in his races to match his consistency and we are hopeful there may be improvement to come. At the time of writing he has an official BHA rating of 70.

He was claimed on 11<sup>th</sup> December 2018 at Southwell for £8,400 + VAT (£8,000 plus the 5% buyers premium) and has been sold to the Northgate Grey Partnership at this price with no added fees. Training costs will commence on 12<sup>th</sup> December 2018 and it is intended for the partnership to run until 30<sup>th</sup> November 2019.

**Each 5% share costs £1,480.00 to include purchase plus training and racing costs to 30.11.19**

This may be paid in full, or by an initial payment of £600.00 due on application and followed by 11 equal monthly instalments of £80.00 commencing on 30<sup>th</sup> January 2019.
